Others present were members of the election committee, Carma James, Laura Giesler, Marilyn Long as well as Andrea Crittendon, who is a member of the Architectural committee and a candidate for a Board position in the up coming Annual Homeowners meeting.

First item discussed was the procedure for the submission of proxy forms for homeowners who are unable to attend the annual meeting. The election committee and Board members Evelyn Strong and Mary McDermott will meet on the evening of February 16 to prepare the ballots and assign the proxy's to the designated proxy holder.

Park Report by Bruce Bollinger:

Numerous homeowners have expressed their appreciation for the brighter lights, which may decrease the car prowl incidences. All homeowners are reminded to be sure they never leave anything visible in their vehicle, and keep it locked at all times.

The appeals committee recommendation concerning a fine for garbage can left out on Winfield was approved on a motion made by Bill, second by Greg. There were no dissenting votes.

Mary reported on contact with one Wayne Royall, who passed out flyers advertising his business throughout the Park. At her insistence, he removed all of them the next day. Park rules prohibit any soliciting within Park boundaries.

Bruce presented a letter he composed outlining the Board position of the need for a special assessment to refurbish the exterior of homes in Barrington Park. The Board members read the letter, making several corrections. Greg made motion to accept letter as corrected, second by John. Motion passed. All Board members signed the letter, which will be given to homeowners.

One complaint about loud music was reviewed. This has been an ongoing problem for some time. Greg made motion to assess a \$50.00 fine. Second by Katie, motion approved.

Meeting adjourned at 7:30 p.m., followed by a cake and ice cream farewell for John Bria, who is moving to Texas.
