IT WAS AMENDED TO READ 2 MONTHS ON THE MONTHLY HOA FEES AND TWO QUARTERS ON THE ASSESSMENT FEES. DONNA SECONDED, AND IT WAS PASSED UNANIMOUSLY.

MICHAEL REPORTED THAT WE NEED REPLACE B ON THE BOARD. AS PER THE CC&R'S THE BOARD OF DIRECTORS MAY SELECT A REPLACEMENT. SUGGESTIONS WERE TAKEN AND MICHAEL WILL CONTACT RANDY COPPLE AND SCOTT BABKA AND CINDI ATHMAN AND SEE IF THEY WOULD BE INTERESTED IN REPLACING B FOR THE REMAINDER OF HIS TERM. IF THEY WOULD LIKE TO DO THIS, THEY WILL BE INVITED TO NEXT MONTHS MEETING FOR THE BOARD TO MEET, AND A DECISION CAN BE MADE.

WE ASKED IF DELORIS WOULD LIKE TO RETURN TO THE BOARD AND SHE DECLINED.
