Four workers laid off for the winter now have five workers plus Mike.

Barrington Park purchased a golf cart from The Hagblooms, (one of our carts is unrepairable) the amount they owe Barrington Park for wood for their unit will be deducted from the total; we will pay them \$448.00 the cart is in good shape and should last a long time.

A car was stolen on Winfield Road.

One new Homeowner: Fatz at 4313 Rugby Court.

All renovation coating has been completed for this year.

The crew will work on the wood buildings during the winter and then in April they can start painting.

## **BOARD DICISIONS:**

Lien will be started due to lack of payment of fine.

We received four responses to letters that were sent out on complaints.

We have not received a response on two letters, will follow-up later.

Received a new bid on the needed pool work from Serenity Pool (out of California) for \$15,000.00 this will cover keeping the kiddy pool, all pipe changes needed, putting in a new pump and stumping for the solar system, this is a savings of \$12,000.00 on the other bids and would not have included the kiddy pool, we will not need to re-plaster for at least five years due to the marble content in the plaster now (they do not put this in pools anymore). It was approved by all board members to have Serenity Pool do the repair work starting immediately.

The board will start calling homeowners in March this will be a follow-up as to the completion of any requested job orders, this will determine if they were done in a timely manner and if they have been completed.
