- Service in the Association -As we approach the summer months, some of you may wonder how the Barrington Park Homeowners Association is run. While it is true that there is a Board of Directors (comprised of nine members who are elected by the members of the Association) and a property manager (the Board has contracted DFI Property Management to manage the property, with Bruce appointed as the office manager), there are also a number of committees which have been formed to handle different areas of the Association. For example, the Architectural Control Committee approves any repairs or modifications that are done to the exterior of units, and the CC&R committee reviews the needs of the Association and incorporates them into the CC&Rs when appropriate. Both of these committees, as well as every other committee of the Association, rely on the service of Association members for their existence and function. Without the hours of service put in by members of the Association, the committees would cease to function and that, in turn, would put vast amounts of pressure on the management of the Park.

#### - MID-SUMMER -

By the time you get this letter, the summer application of fertilizer and weed control will have been applied. On July 28<sup>th</sup>, an insecticide for bugs that are eating up some pretty big patches in the lawn was sprayed. Just as a reminder, when it gets this hot, Mother Nature does her best to preserve the grass by telling it to go dormant. As soon as it cools a little, it will come back with full glory, so please bear with us a little as we try to strike a balance between water conservation and keeping it lush green.

#### - Insects -

Barrington Park has a policy that we allow nature to take its course concerning most insect control. That is, if they live outside, we usually do nothing. Ants, gnats, and other insects are often eaten by other insects or animals. If these pests are invading your home, we suggest you purchase a perimeter spray (available at most grocery or hardware stores) and spray around your doors and windows. Please be careful with any spray you use, as we have a lot of birds and other animals around the grounds. Salt Lake County provides mosquito control for all our ponds and waterways on a regular basis. Owners can assist with mosquito control by ensuring no standing water is allowed in containers on porches and patios. Barrington Park will assist with yellow jack control if they build a nest on the exterior of your home.

### - WATERING SCHEDULES -

The sprinklers come on at night and in the early morning hours three times a week. Usually (depending on rain and heat), those cycles are about 7 minutes in length three times during the period. This is to allow maximum soaking and avoiding run off. Do not be alarmed if you see an area getting watered more than once in one night, as that is part of the plan. As always, residents are encouraged to report any broken sprinklers or heads that do not operate correctly.

**— PONDS —** We have made numerous calls to State and County agencies trying to come up with some sort of solution to the algae problem we have in our ponds. As of yet, they have provided no workable solutions due to our water running into the Jordan River.

### - Pool -

Thanks so much to all that use the pool. You have been just great this year concerning courtesy and cleanliness. In return for your hard efforts, it has been our hard effort to give you the cleanest pool possible. As you know, the pool underwent major renovation and is one of the best in the city. We have had to learn how to deal with the new isolated wading pool, but we think we have it all figured out. Again, we receive many comments of how great a pool operation Barrington Park has. Congratulations to the swimmers, the monitors, and the maintenance people. For your information, the pool will close for the season at 9:00PM on the 6<sup>th</sup> of September (Labor Day).

- **BEST-LOOKING GARDEN AWARDS** - On August 20<sup>th</sup>, gift certificates in the amounts of \$25, \$50, and \$75 will be awarded to the homes that have the best-looking yard. Many of you do a great deal around your homes to help add to the beauty of Barrington Park, and the Board and Grounds Committee think you ought to be recognized for your efforts. Those of you who have not started yet still have plenty of time to get those flower beds going, so start cleaning, planting, and having fun! Prizes will be donated by our property management company, DFI.

### - HOA DUES BY CREDIT CARD -

We just finished the paperwork which will allow you to pay for your monthly dues and special assessments by credit card! Not only do we now have the ability to take one-time payments, but we can actually setup recurring monthly transactions that are added to your credit card around the same day each month. No more writing checks or having to remember to make the payments. Unfortunately, due to the nature of how credit card companies make money, we will need to charge a "convenience fee" of seven dollars when you pay by this method. •Getting final cost figures on 4 more roofs to be done this year. Based on evaluations of mostneeded, they are 1154/58 & 1218/22 Middlesex, 1151/55 Norwalk, and 4225/29 Derbyshire.

•Requested information on Winfield homeowner concerning their desired patio fence replacements. Gave suspense date to July 9<sup>th</sup> or configuration would remain the same as it is now.

 $\cdot 3^{rd}$  application of fertilizer to be applied about May  $12^{th}$ .

Solar panel structure is up. Tying new system into the old this week. Will paint bottom as soon as all testing and acceptance is complete.
Renovation painters are now in full operation.
4 wood buildings complete, slated last 2 wood buildings and moving to regular buildings.
13 buildings are repaired and ready for paint crews.

- FROM FINANCE AND MANAGEMENT -

When making payments, please make sure your Barrington Park address appears somewhere on the check or money order. Your address is your account number and doing so helps ensure your payments get posted to the proper account. You do not need to write two separate checks for the regular and special HOA dues, unless you want to for your own accounting purposes. Anything above what your normal dues are will be applied to any special dues unless you indicate differently. Payments received are first applied to the regular HOA dues and then to any special dues. Regular HOA dues are due the 1<sup>st</sup> of the month, even if you do not get a statement until sometime later. <u>A late charge of \$25 will be charged for any</u> payment received after the 25<sup>th</sup> of the month.
