- RESCHEDULED ANNUAL MEETING -

The Annual Meeting of the Barrington Park Homeowners' Association was scheduled for February 18th, 2010. Unfortunately, not enough members were present either in person or by proxy to make the meeting valid in accordance with the CC&Rs. Consequently, the meeting was adjourned. The meeting has been rescheduled for March 18th, 2010, and will be held in the office. The only order of business will be to elect three members to the Board of Directors. At the meeting, only 2% (six members) of the Association are required to be in attendance to make the meeting valid. Although there may be standing room only, we encourage owners who have not already voted to attend the meeting and vote, or obtain an absentee ballot from the office and turn it in before March 18th, 2010.

- Ponds -

We've had a mild winter, and although there will probably be a few snowstorms left, we are gearing up for spring. For the second time in the history of the Park, we have run the fountains in the ponds year-round. With a little luck and a bit more rain and snow, we hope to keep them flowing throughout the year. The pond closest to 1300 West has been dredged and is two feet deeper than it has been in the past; this new depth will help water quality. However, with the water comes a few safety concerns. Parents, please caution your youngsters about the ponds and water hazards; children should never play in the ponds, and should only play near the ponds with adult supervision. As always, we will continue to spray and bait for mosquitoes. However, residents should always take the necessary precautions.

— BUILDING REPAIRS —

If you feel that there has been damage to your home that is the responsibility of the HOA, you must notify the property manager before any repairs are made. The Association will not reimburse owners for repairs that are made without the approval and involvement of the Board.

When making payments please make sure your Barrington Park address appears somewhere on

the check or money order. Your address is your account number and doing so helps ensure your payments get posted to the proper account. Regular HOA fees are due the 1st of the month, even if you do not get a statement until sometime later. A late charge of \$25 may be charged for any payment received after the 20th of the month. As stated in the CC&Rs, 18% interest is charged per year on the unpaid balance of all accounts.

The following accounts have been delinquent on maintenance fees for 60 days or longer. As a result, liens have been placed or are in progress. Requests for judgments and foreclosures have started for chronic delinquencies.
