**PARK REPORT:** 

Bruce went over the balance sheet and the profit and loss reports, He talked about the problem accounts, these are down \$ 1,562.10 from last month; total past due is \$29,260.43, two new lien filed, foreclosure process was started on three units, 4319 Abby Ct., 4311 Abby Ct. and 1208 Middlesex Road. There are three Trustee's sales started on 1184 Southampton, 4307 Haverford Ct, and 4237 Derbyshire, we will go for a judgment on these.

Two Bids's for fertilizing Total Landscape Management \$6,100.00 and True Green is \$6,557.00 (board approved to go with Total Landscape Management).

## **BOARD DECISIONS:**

Eldon suggested that a policy be adapted in regards to reimbursement for repairs to lots. A work order must be submitted to the property manager prior to any repairs being done. Work can not be started or completed by the homeowner and then the homeowner expects reimbursement from the Association.

A motion was made to drop \$200.00 (late fees prior to the change of the CC&R'S) from total past due balance of \$3,278.12 on the property at 4307 Cromwell with the stipulation that if he doesn't remain current for one year all fees will be reapplied and he must bring account current. This was approved by all board members except Elden Bodily (he believes the board should forgive all \$300.00 of the late fees that were charged before the current CC&R'S were approved and that if Mr. Andrews falls behind again the board should foreclose immediately. He believes the board should not forgive a debt then reinstate the debt later.

Board approved to accept \$65.00 per month plus interest from Barbara Mosher through American Credit Foundation, this property is up for a Trustees Sale if she doesn't keep this payment we can still go for a judgment for the past due amount of \$2,890.45.

Request to have garage painted due to the courtesy of maintenance patching some holes in garage ceiling (DENIED).
