## **—SWIMMING POOL RULES & REGULATIONS—**

### **POOL HOURS**

11:00am – 9pm (Monday through Friday)

10:00am – 9pm (Saturday and Sunday and Holidays)

### **IMPORTANT NOTICE**

**\*\*The Barrington Park swimming pool does not have an on-duty lifeguard. Any Barrington Park personnel present are pool monitors and are present to ensure a smooth operation only. Swimming is done at your own risk.\*\***

### **DEFINITIONS**

"Resident" – An individual permanently residing at Barrington Park. Non-resident owners' rights to pool use are transferred to their tenants.

"Family"/"Guest" – An individual not residing at Barrington Park who is invited by a resident to use the facilities.

"Pool Area" – The area including and surrounding the swimming pool, enclosed by the encircling fence and the Barrington Park office.

### **RULES**

1) The Barrington Park swimming pool is a private pool, and is maintained for the use of residents and their invited guests. All individuals must register with the pool monitor upon entering the pool area, and anyone in the pool area who is not registered will be asked to leave. Pool residents must bring identification that shows they live at Barrington Park.

2) Residents **MUST** be at the pool when they have a guest using the pool. The register must be signed indicating both the number of residents and the number of guests using the pool. Residents have the responsibility to advise their guests of all the pool rules. Residents are also responsible for the conduct and safety of any family and guests using the pool.

3) Respective parents shall be solely responsible for the safety of any child. A child under 16 years of age must have an adult of at least 18 years of age at poolside. 16 and 17 year old residents may use the pool without a resident adult at poolside as long as their parent has signed a parental consent form for the resident minor. 16 and 17 year old residents may bring a guest as long as they have a consent form on file, and their guests are at least 16 years old and have a parental consent form.

4) All individuals shall cooperate in maintaining maximum cleanliness and tidiness in the swimming pool and restroom areas. No children are allowed in the pool who are not toilet trained unless they are wearing swimmers' diapers in addition to rubber or plastic pants over the diapers. Regardless to toilet training, parents are encouraged to have their children use the toilet facilities every half hour or so. Health regulations require certain strict procedures be followed if the pool becomes contaminated, and pool

closure is likely when "accidents" occur. In consideration of other swimmers, parents should do everything possible to eliminate "accidents".

5) No diving. No flips of any sort are allowed. No rough play, shoving or pushing of people into the pool. Running is not allowed. No hanging or swinging on the rope.

6) Attire should conform to conventional swimming suits. No outerwear—including cut-offs or shorts—will be allowed in the pool. T-shirts are allowed, provided they are light in color and will not be bleached by chlorine.

7) No pets are allowed in the pool or pool area.

8) All individuals must take a shower before entering the swimming pool, provide their own towels, and wear foot attire from their residence to the pool to prevent contamination in the pool. Not using footwear to the pool area will be cause for being denied access to the pool. All bathers must shower after using the bathroom.

9) No glassware, glass bottles, or the like are allowed in the pool area. Food or beverages are not allowed in the pool. Food may be consumed on the lawn area only. No alcoholic beverages are permitted at any time. No smoking is allowed anywhere inside the fenced pool area. Smoking is allowed outside the fenced pool area as long as cigarette butts are not discarded on the grounds.

10) No screaming, voice games, ball games, rough play, or any activity that would prevent general swimming is allowed, nor is any spitting, spouting water, or blowing nose in the pool. Please behave in a considerate manner to others present and to residents living in the surrounding area. Swim rings, inner tubes, rafts, and toys are to be kept out of the pool when not in use. Profanity at any time or for any reason is cause for immediate suspension of pool privileges.

11) Any individual having any apparent skin disease, sore or inflamed eyes, cough, cold, or any communicable disease are asked to refrain from entering the pool. Anyone who has had diarrhea within the two weeks should not enter the pool.

12) Each resident shall be responsible for any damage caused to the pool, its facilities, or equipment by said resident or any family or guest of the resident. Resident shall pay for any damage, including pool closures and associated "shock treatments" due to "accidents" caused by their children.

13) Any resident who is delinquent with association fees or special assessments will forfeit their right to use any of the recreational facilities, including the pool.

14) The swimming pool rules must be complied with by all residents, family, and guests. Each resident, Board of Directors member, pool monitor, maintenance person, and manager is responsible to see that the rules are correctly enforced. Individuals breaking rules are subject to possible forfeiture of swimming pool privileges.

15) Pool monitors have the authority to take whatever steps necessary to maintain a safe, clean, orderly, and enjoyable swimming experience for all residents. This includes asking bathers to remove or limit toys, and limit the numbers of guests, noise, or other activities. Please help and respect them in carrying out their responsibilities.
