MESSAGE FROM THE HOA PRESIDENT-DIRK HEINZ:

April 2020

Being aware of your family, your friends, your neighbors and the challenges they are facing is critical because the enforced separation can cause people to feel disconnected from each other.

Please remember to check on those around you to make sure that they are ok. Just asking someone how they are doing can help them feel like others are there for them when they are spending most of their days alone.

It can be as simple as smiling and saying hi when you are walking around the park (and staying 6' from one another).

I look forward to seeing us emerge from this crisis as a stronger community, please don't hesitate to let me know your thoughts or ideas on this or any other subject facing our Barrington family.

PREVENTING THE SPREAD OF COVID-19:

The board, in consultation with management, insurance providers and other business partners, has been planning for contingencies that may arise in the community as a result of the spread of COVID-19.

Based on advice that has been circulated by the Centers for Disease Control and Prevention and the Salt Lake Department of Health, we have detailed some possible scenarios and our current plans to deal with them. These plans are subject to change based on CDC guidance and advice from our professional partners.

- **Management Office:** For the safety and wellbeing of residents and management, the office will be closed to all visitors. Management will be onsite, but the office will remain locked. If you need to contact management, please contact them either by phone at (801) 263-3628 or via email at <u>office@barringtonparkhoa.com</u>. Payment of the HOA fees can be dropped through the mail slot of the front door.
- **Cleaning:** The crew has been cleaning, disinfecting, and wiping down surfaces in common areas. It is advised that the playground area not be used during this pandemic until further notice. Owners are responsible for their private property.
- Social Distancing: Many experts also are urging people to practice "social distancing," which is the idea of maintaining a roughly 6-foot distance between other people. It also means limiting nonessential travel, working from home, and skipping social gatherings.
- Meetings & Events: The CDC has recommended against any gatherings of 50 or more people through the middle of May. That's why we are postponing all nonessential meetings.

If you get sick...

Medical authorities are strongly urging all persons who exhibit symptoms to stay home and avoid public spaces unless you need medical care. You also should separate yourself from other people and pets in your home.

If you need to need to visit a doctor or get tested for COVID-19, develop a plan before you go:

- Call ahead before visiting your doctor.
- Wear a facemask if you are sick.
- Cover your coughs and sneezes.
- Clean your hands often.
- Avoid sharing household items, such as utensils, plates, glasses, and towels.
- Clean all "high-touch" surfaces, such as counters, tables, doorknobs, bathroom fixtures, phones, keyboards, and remotes.

This board will not and does not make any of the decisions mentioned above lightly. These actions are being taken to ensure the health and welfare of the residents of Barrington Park.

It is also incumbent upon residents to take this situation seriously and do their part to minimize the spread of this deadly disease. The board highly encourages you to review safety guidelines and look for updates from the CDC, the local health department, and the World Health Organization.
