**POOL ANNOUNCEMENT/UPDATE:** We all hope you are staying safe and healthy during these uncertain times.

The Board of Directors has decided that the pool will remain closed until further notice.

This decision is based on consultation with the HOA's Attorney and Insurance provider, as well as the State and local Health Department restrictions & recommendations related to Covid-19, as the infection rate continues to accelerate (daily infection rate is currently 4 times greater on a daily basis than when the decision to remain closed was made in mid-May).

While there may be other pools, clubhouses and gyms open in the area, the Barrington Park Board of Directors remains committed to the health and safety of all residents during this time while we see the number of Covid-19 cases increasing.

The Board of Directors is committed to staying informed about the situation and will re-visit the possibility of opening the pool on or around August 1<sup>st</sup>, if conditions permit.

In the meantime, please stay safe and healthy.

**<u>FIREWORKS</u>**: Barrington Park will allow legal State of Utah and Taylorsville fireworks, except aerials, this year for the 4th and 24th of July. However, we ask that you use extreme caution so as not to cause damage to buildings, parked cars, common areas and especially people.

Please be courteous and mindful that you live in a community where you are near your neighbors. Some of those neighbors and/or pets do not appreciate fireworks. You are required to pick up all fireworks residue and trash left behind. Please complete your fireworks by 10:30 PM. Use of illegal fireworks will cause an immediate \$100.00 fine to be issued against the homeowner. Have fun, be happy and be safe!

<u>PET REGISTRATION: THIS IS A REMINDER!</u> All pets must be registered with the office, this Rule went into effect on January 1,2020, information about this has been in the newsletters for the last year. As of July 1, 2020, we will start imposing the \$50.00 per month-approved fine on anyone that is not in compliance with this Rule.

**PAPER DUMPSTER:** The paper recycling bin, north of the tennis courts, is to be used for recycling of paper products only. Not doggie bags, plastic, glass, styrofoam, food waste, house trash, cans, and the list goes on and on. When the paper and cardboard products are contaminated with garbage, they are required to throw away the whole bin. Consequently, it costs them money to do so, we don't get any money for the paper, and it is simply unhealthy.

Please do not throw anything other than paper or cardboard in the bin. **PLEASE REMEMBER TO FLATTEN BOXES**. Un-flattened boxes take up too much room and fills up the bin quickly. Thanks for your help. Working together we can keep the bin.
